New Mexico has 12 NAWCA projects either completed or underway. These projects have conserved 22,632 acres of wildlife habitat. NAWCA funding of more than \$5.5 million stimulated partner contributions of over \$15 million. These figures do not include multi-state projects.

MIDDLE RIO GRANDE WETLANDS PROJECT

Continued altering of the hydrology of the Headwater Grande and its tributaries has led to a severe decline in the surrounding wetlands and an invasion of exotic brush, primarily salt cedar and Russian olive. An estimated 60 percent of the wetlands in the middle Headwater Grande Valley were lost between 1935 and 1989. The valley serves as a key migration funnel and wintering area for migratory birds in the Southwest. Tens of thousands of waterfowl and other migratory birds use this area as wintering grounds or as a stopover point to the interior highlands of Mexico. Virtually the entire population of Rocky Mountain sandhill cranes winter there.

This project will acquire 58 acres of oxbow wetlands and restore 2,579 acres of floodplain forest, wet meadow, moist-soil and other wetland habitat types. Partners will restore habitat on four key federal, tribal and municipal sites in the valley, including 531 acres on the Bosque del Apache National Wildlife Refuge (NWR), 415 acres on the Sevilleta NWR, 177 acres of bosque wetlands owned by the Pueblo of Santa Ana and 58 acres of oxbow wetlands owned by the City of Albuquerque. This project will benefit 21 waterfowl species, primarily mallards and pintails, nearly 100 other species of wetland-associated birds and 11 threatened or endangered species, including whooping cranes and southwestern willow flycatchers. The project area contains some of the most significant, publicly owned wetlands in the region.
